## I. Introduction

### **Intranet**

The term *Intranet* refers to a corporate or private network of computers, that share part/parts of the organizations operations and information with employees. By using secure network connections and specific internet protocols. In certain situations, the term refers to only the most visible service, the organizations internal website. The same concept is used to build an intranet, using technology to run clients and servers on the same internet protocol suite. Common internet protocols as HTTP and FTP are commonly used. Often, there are attempts to use internet technologies to accommodate new interfaces to corporate “legacy” data and information systems.

Additionally, a *Intranet* can be understood as a “private” version of the organizations own internet. Or seen as a version of the internet confined to an organization.

### **Electronic Business**

The term E-business (electronic business), is derived from terms such as “e-mail” and “e-commerce”. E-business is the conduct of business communication on the internet. Buying, selling and servicing customers while collaborating with business partners through the internet. The first company to use the term “E-business” was *IBM*, when launching a thematic campaign based on the term.

Companies use the world wide web to purchase parts and supplies, networking with other companies and collaborating on sales promotions. Sharing common knowledge and research, exploiting the availability and convenience of the reach of the internet. Internet giant *Amazon.com*, known for their book sales, is one example of a successful E-business.

Today, major corporations are rethinking E-business due to potential security risks and culture that has the capability to use it.

A new trend is taking place on the internet, a more direct selling or e-tailing method using computer-related equipment and software. *Dell Computer* being the first to report sales in the millions, using internet e-sales. Significant to the travel industry, bookings are now made directly

or indirectly as a result of the web. Boosting travel and transportation sales immensely, a travel agent is no longer needed at this point. Custom or unique goods are considered great business prospects for the future.

With security built into most of today's browsers, and digital certificates now available from *Verisign*, Individuals can become certified issuers. *IBM* considers the development of Intranets and Extranets to be a large part of e-business. E-business can include e-service, which is the provision of services and tasks over the internet, by the application service providers. Otherwise known as the term ASP. (1)

### **Extranet**

Private networks that use internet protocols are called Extranets. They work by using network connectivity, and public telecommunication systems to share parts of organizations information. Actions and operations are then conducted with suppliers/vendors, partners, customers and other businesses. An extranet can be viewed as a part of a company's intranet, that is extended to users outside the company (e.g. normally over the internet). It has also been described as a "state of mind" in which the internet is perceived. A way to do business with a pre-approved set of companies, business- to- business or B2B. In isolation from all other internet users. In contrast, business-to-consumer or B2C involves known server(s) of one or more companies.

Furthermore, an extranet can be understood to be a private intranet mapped onto the internet or another transmission system not accessible to the public. Managed by more than one company's administrator(s). For example, military networks of different security levels may map onto a common military radio transmission systems, that never connect to the internet. Any private network mapped onto a public one, is a virtual private network or VPN. In contrast, an intranet is a VPN under the control of a single company's administrator(s).

## **II. Body**

### **Advantages of Intranet**

**1. Workforce productivity:** Intranets can help public. and view information faster, while using applications relevant to their roles and responsibilities. Web browser interfaces such as Internet Explorer, Firefox and Google Chrome. Users can access data held in any database within the organization. Subject to security provisions, users can access the available data anytime, from anywhere within the company/organization. **2. **3. Communication:** Intranets can serve as powerful tools for communication within an organization. From a communication standpoint, Intranets are useful to communicate tactical initiatives that have global reach. The type of information to be conveyed is the purpose, the goal, e driving force, the results to date and whom to speak to for more information. By communicating this information on the intranet, all staff can access the initiative and stay current with the progress and tactical focus of the organization.

1. *Web Publishing:* Corporate knowledge is easily maintained and reached, using hypermedia and Web technologies. Some examples include: employee manuals, benefit documents, company policies and common training policies. Most of these types of files can be reached using common applications as Acrobat files, Flash files, and CGI applications. Allowing each business unit to update/input data on the document therefore, the most current information is always accessible. Available to all employees sharing the intranet within the organization.
2. *Business Operations & Management:* Intranets are also used as platforms for developing and deploying applications to support business operations and decisions throughout the enterprise.
3. *Cost-Effective:* Users can view information and data via web-browser rather than maintaining physical documents such as procedure manuals, internal phone lists and requisition forms.
4. *Promote Common Corporate Culture:* Every user is viewing the same information within the intranet.
5. *Enhance Collaboration:* With information easily accessible by all authorized users, teamwork is enabled.

### III. Disadvantages of Intranet:

3. The need for expertise in the field to administer and develop intranet information within the organization
4. Security of the intranet can become an issue. Some users may post sensitive information which appears to another user. Furthermore, in an industry with high turnover the potential to acquire sensitive information for future gain at a competing company.
5. With multiple users, information overload can occur, if not controlled well

### IV. Planning And Creating A Intranet

Organizations spend a considerable number of resources, planning and building the intranet system. It is strategically important to the organizations success, some of the planning would include steps as:

- Choosing the organizations goal or what they hope to achieve from the intranet
- Delegating the persons or department in control of the technology and implementation
- Choosing a duration for the existing system to be phased out/replaced
- Methods of security for the organizations intranet system
- Discuss and implement any legalities or other constraints
- Choose the level of interactivity (e.g. wikis, on-line forms) desired
- Will new data entry/update of existing data be centrally controlled or delegated out

In addition, to the hardware and software decisions, participation issues and features are to be supported. Systems that must be put into place for legalities, and to protect the organization, from those that may want to cause harm. Organizations must educate employees, abiding by strict guidelines with consequences for violating the systems. These systems include:

- Content Management Systems
- Ethics Systems

- Harassment Clauses
- Confidentiality Clauses

The implementation includes these steps:

1. User involvement to identify user's information needs
2. Setting up web servers with current hardware and software
3. Setting up web server access using a TCP/IP network
4. Installing the user programs on all required computers
5. Creating a homepage to host the content
6. Testing and promoting the use of the intranet with user involvement

**Networked**

To send, your computer simply contacts the e-mail networks and forwards the message tagged to the intended recipient. **E-mail Messaging**

E-mail messaging gives your business a competitive edge. It allows you to quickly, and accurately keep all your employees/customers current on offers, promotions, and opportunities. Taking only minutes to compose and send. You will never have to leave your name and number with a secretary again. The message is available to the recipient within a few seconds, after you send it. E-mail saves paper, and sending out a mass message as easy as sending one. In fact, several publishing companies are now e-mailing time-critical newsletters to several thousands of subscribers every week.

**File Transfers**

Messaging is just a special form of computerized file transfer. Except, file transfer is accomplished through one computer to another vs. more than one at a time. File transfer is the simple process of copying one file, from one computer, to another. The only difficulty with file transfer is that some do not transfer with the original text. These files are: word processing documents, electronic spreadsheets, and graphic images. Some contain characters that require *data transfer protocol*. There are many "data transfer protocols" in common use today. It does not matter which one is used, since the computers sending and receiving agree on the transfer.

The data transfer protocol adds a layer of encoding to the file transfer process, verifying each group of characters in the file is received correctly.

File transfers are the most efficient way to work-at-home offices and representatives, in touch with the home office. For example, if all offices fill out a standard spreadsheet, with daily or weekly sales, it can quickly transfer to a home office. Consolidating all company data, to provide one up-to-date spreadsheet for the company. File transfer also allows users to attach and add to documents, far more efficiently than a face to face meeting. Shifting databases allows analysts to make forecasts from the recent and completed data.

**On-line Retrieval**

On-line data retrieval is potentially the most profitable use of computer communications. There are several thousands of databases of information available, for any communicating computer to search and copy from. The information can range from detailed technical data, registered patents, to simple general business information. You can find government procurement invitations, daily stock quotes and investment analysis. Dun & Bradstreet's provide summaries on over 1,000,000 corporations.

You can also tap into daily newspapers, yellow pages, TRW credit data, and Harvard business review. The possibilities are endless, for on-line data retrieval in these times and ages. However, take a moment to imagine the endless possibilities if you could identify your competitions marketing tactics.

You can research and target your customers immediate and future needs, reach hundreds of potential new customers, and compare suppliers pricing trends.
